Ensure that where signatures are required, you submit the **original signed version** of each completed paper. Documents without original signatures cannot be accepted.

Candidate's consent	
For each candidate listed on the nomination form a consent to nomination declaring all of the information listed below must be completed.	
Must be a qualifying Commonwealth citizen, a citizen of the Republic of Ireland or a European Union Citizen and not require leave to enter or remain in the United Kingdom or have indefinite leave to remain. Must also be 18 years old or older on the date the form is signed.	
Must declare meeting at least one of the listed qualification(s) crossing through any that do not apply. Those left should match the qualification(s) given on each candidates home address form.	

¹ This is not to be used for London Mayoral elections or Constituency candidates standing for the London Assembly.

Must not sign the form if disqualified to stand. Read the Electoral Commission guidance on standing for election as well as the legislation listed. If you are not sure if you are able to stand you should contact your employer (where relevant), consult the legislation or, if necessary, take independent legal advice.	
Add full date of birth.	
Sign and date the document in the presence of another person not earlier than one calendar month before the deadline for submitting your nomination papers.	
Get the other person to complete and sign the witness section. This should be the same person whose details are provided as the witness on the home address form.	
Method of submitting the form to the GLRO: in person, by hand (but not limited to a candidate or the Nominating officer or someone authorised to act on their behalf). It cannot be submitted by post, fax, e-mail or other electronic means.	
Request for party emblem	
Write the name or description of an emblem registered by the party and published on the Electoral Commission's website.	
Ensure the request is signed by the party Nominating Officer or a person authorised in writing to act on their behalf.	
Method of submitting the form to the GLRO: in person (but not limited to a candidate) or by post. It cannot be submitted by post, fax, e-mail or other electronic means.	
Appoint an election agent (all candidates)	
Give the name and address of the appointed election agent. If you choose to act as your own agent but do not provide an office address, your home address will be published on the notice of election agents. This will be the case even if you have requested to withhold this information on the home address form. If you do not appoint an agent, the first named candidate on the list will become the agent and their home address will be published on the notice of election agents even if they have requested to withhold the information on their home address form.	
The appointed agent should sign the form showing their acceptance.	
Method of submitting the form to the GLRO: in person (but not limited to the Nominating officer or someone authorised to act on their behalf) or by post.	
Notification of sub-agent (all candidates)	
An election agent may appoint one or more sub-agents to act on their behalf. Election agents may appoint sub-agents for particular parts of the Greater London authority area, as long as those parts do not overlap. The election agent can determine the parts into which they wish to sub-divide the Greater London authority area.	
Give the name and address of the appointed sub-agent

Section 21 of the Greater London Authority Act 1999

Disqualification from being the Mayor or an Assembly member

- A person is disqualified from being elected or being the Mayor or an Assembly member if--(1)
 - (a) he is a member of staff of the Authority 2;
 - (b) he holds any of the offices or appointments for the time being designated by the Secretary of State in an order as offices or appointments disqualifying persons from being the Mayor or an Assembly member;
 - (c) he is the subject of a bankruptcy restrictions order or an interim order:
 - (d) he has within five years before the day of the election, or since his election, been convicted in the United Kingdom, the Channel Islands or the Isle of Man of any offence and has had passed on him a sentence of imprisonment (whether suspended or not) for a period of not less than three months without the option of a fine; or
 - (e) he is disqualified under--
 - (i) section 85A or Part III of the Representation of the People Act 1983, or
 - (ii) section 17 or 18 of the Audit Commission Act 1998,

from being elected or being the Mayor or an Assembly member.

- Subsection (1)(a) does not prevent a person appointed under section 67(1)(b) as the Deputy Mayor for (1A) Fire, or appointed under section 67(1)(b) and designated as the Deputy Mayor for Fire, from being elected as or being an Assembly member.
- (2)A paid officer of a London borough council who is employed under the direction of--
 - (a) any of that council's committees or sub-committees the membership of which includes the Mayor or one or more persons appointed on the nomination of the Authority acting by the Mayor, or
 - (b) a joint committee the membership of which includes one or more members appointed on the nomination of that council and one or more members appointed on the nomination of the Authority acting by the Mayor,
 - (c) the executive or any committee of the executive of that council, where that council are operating executive arrangements and the membership of that executive includes the Mayor or one or more persons appointed on the nomination of the Authority acting by the Mayor, or
 - (d) a member of the executive of that council, where that council are operating executive arrangements and that member is also the Mayor or a person appointed on the nomination of the Authority acting by the Mayor,

shall be disqualified from being elected or being the Mayor or an Assembly member.

- In this section "executive" and "executive arrangements" have the same meaning as in Part II of the Local [(2A) Government Act 2000.
- ...* (3)
- (4)
- For the purposes of subsection (1)(d) above--(5)
 - (a) the ordinary date on which the period allowed for making an appeal or application with respect to the conviction expires, or
 - (b) if such an appeal or application is made, the date on which the appeal or application is finally disposed of or abandoned or fails by reason of its non-prosecution,

shall be deemed to be the date of the conviction.

- This section shall apply in relation to being returned as a London member under section 11 above (6)otherwise than at an election as it applies in relation to being elected.
- References in this section to election shall accordingly be construed as if a London member so returned (7)were elected at an election on the day on which he is to be treated as returned.

Section 34 of the Localism Act 2011

Offences

- A person commits an offence if, without reasonable excuse, the person—
 - (a) fails to comply with an obligation imposed on the person by section 30(1) or 31(2), (3) or (7),
 - (b) participates in any discussion or vote in contravention of section 31(4), or
 - (c) takes any steps in contravention of section 31(8).
- (2) A person commits an offence if under section 30(1) or 31(2), (3) or (7) the person provides information that is false or misleading and the person—
 - (a) knows that the information is false or misleading, or
 - (b) is reckless as to whether the information is true and not misleading.
- (3) A person who is guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 5 on the standard scale.
- (4) A court dealing with a person for an offence under this section may (in addition to any other power exercisable in the person's case) by order disqualify the person, for a period not exceeding five years, for being or becoming (by election or otherwise) a member or co-opted member of the relevant authority in question or any other relevant authority.
- (5) A prosecution for an offence under this section is not to be instituted except by or on behalf of the Director of Public Prosecutions.
- (6) Proceedings for an offence under this section may be brought within a period of 12 months beginning with the date on which evidence sufficient in the opinion of the prosecutor to warrant the proceedings came to the prosecutor's knowledge.
- (7) But no such proceedings may be brought more than three years—
 - (a) after the commission of the offence, or
 - (b) in the case of a continuous contravention, after the last date on which the offence was committed.
- (8) A certificate signed by the prosecutor and stating the date on which such evidence came to the prosecutor's knowledge is conclusive evidence of that fact; and a certificate to that effect and purporting to be so signed is to be treated as being so signed unless the contrary is proved.
- (9) The Local Government Act 1972 is amended as follows.
- (10) In section 86(1)(b) (authority to declare vacancy where member becomes disqualified otherwise than in certain cases) after "2000" insert "or section 34 of the Localism Act 2011".
- (11) In section 87(1)(ee) (date of casual vacancies)—
 - (a) after "2000" insert "or section 34 of the Localism Act 2011 or", and
 - (b) after "decision" insert "or order".
- (12) The Greater London Authority Act 1999 is amended as follows.
- (13) In each of sections 7(b) and 14(b) (Authority to declare vacancy where Assembly member or Mayor becomes disqualified otherwise than in certain cases) after sub-paragraph (i) insert—
 - "(ia) under section 34 of the Localism Act 2011,".
- (14) In section 9(1)(f) (date of casual vacancies)—
 - (a) before "or by virtue of" insert "or section 34 of the Localism Act 2011", and
 - (b) after "that Act" insert "of 1998 or that section".
