

# Election of London Members (party list candidates) of the London Assembly 2021

**You must print off the forms in this pack before submitting them.**

**The following papers must be delivered by hand:**

1a: Nomination form

1b: Home address form (part 1 and part 2) to be completed individually by each list candidate

1c: Candidate's consent to nomination (including the pages of legislation) to be completed individually by each list candidate

**The following papers can be delivered by hand or by post:**

2: Request for a party emblem

3: Notification of election agent

4: Notification of sub-agent

The notice of election published by the Greater London Returning Officer (GLRO) will specify the times and exact location to which nomination papers must be delivered.

Ensure that where signatures are required, you submit the **original signed version** of each completed paper. Documents without original signatures cannot be accepted.

## **General Data Protection Regulation (GDPR)**

This checklist is designed to assist party list candidates standing in the election of London Members of the London Assembly election<sup>1</sup> and should be read alongside the Electoral Commission's [Guidance for candidates and agents](#).

Nomination form	
Description –enter a party name or description registered with the Electoral Commission, this must match the details shown on the required certificate of authorisation from that party. Whatever is entered in this box will appear as the description on the ballot paper.	
Add the full names for each candidate (up to a maximum of 25) – surnames in the first box and all other names in the second.	
Optional - Use the commonly used name(s) box(es) if any are commonly known by a name other than their full name and want it to be used instead of their full name.	
Ensure the nomination paper is signed by the party Nominating Officer (or someone that they have authorised to sign it on their behalf)	
Method of submitting the nomination form to the Greater London Returning Officer (GLRO): by hand, by the party Nominating officer or someone authorised to act on their behalf.	
Candidate's home address form	
For each candidate listed on the nomination form a home address form needs to be submitted along with a consent to nomination. Repeat the steps below for each candidate's home address form.	
Add full name.	
Add home address in full.	
Add qualifying address, or qualifying addresses, to each of the relevant qualifications.	
Add the full name and home address in full of the person who will witness their consent to nomination form.	
Please also complete part 2 of the form if home address is not to be printed on the ballot papers, instead give the name of the relevant area or, where outside the UK, the country, in which the home address is situated, and candidate to sign the form. Please submit part 2 of the home address form with the nomination papers, even if not choosing to withhold the home address from the statement of persons nominated, notice of poll and ballot papers.	
Method of submitting the form to the GLRO: in person, by hand (but not limited to a candidate or Nominating officer or someone authorised to act on their behalf). It cannot be submitted by post, fax, e-mail or other electronic means.	
Candidate's consent	
For each candidate listed on the nomination form a consent to nomination declaring all of the information listed below must be completed.	
Must be a qualifying Commonwealth citizen, a citizen of the Republic of Ireland or a European Union Citizen and not require leave to enter or remain in the United Kingdom or have indefinite leave to remain. Must also be 18 years old or older on the date the form is signed.	
Must declare meeting at least one of the listed qualification(s) crossing through any that do not apply. Those left should match the qualification(s) given on each candidates home address form.	

<sup>1</sup> This is not to be used for London Mayoral elections or Constituency candidates standing for the London Assembly.

Must not sign the form if disqualified to stand. Read the Electoral Commission guidance on standing for election as well as the legislation listed. If you are not sure if you are able to stand you should contact your employer (where relevant), consult the legislation or, if necessary, take independent legal advice.	
Add full date of birth.	
Sign and date the document in the presence of another person not earlier than one calendar month before the deadline for submitting your nomination papers.	
Get the other person to complete and sign the witness section. This should be the same person whose details are provided as the witness on the home address form.	
Method of submitting the form to the GLRO: in person, by hand (but not limited to a candidate or the Nominating officer or someone authorised to act on their behalf). It cannot be submitted by post, fax, e-mail or other electronic means.	
Request for party emblem	
Write the name or description of an emblem registered by the party and published on the Electoral Commission's website.	
Ensure the request is signed by the party Nominating Officer or a person authorised in writing to act on their behalf.	
Method of submitting the form to the GLRO: in person (but not limited to a candidate) or by post. It cannot be submitted by post, fax, e-mail or other electronic means.	
Appoint an election agent (all candidates)	
Give the name and address of the appointed election agent. If you choose to act as your own agent but do not provide an office address, your home address will be published on the notice of election agents. This will be the case even if you have requested to withhold this information on the home address form. If you do not appoint an agent, the first named candidate on the list will become the agent and their home address will be published on the notice of election agents even if they have requested to withhold the information on their home address form.	
The appointed agent should sign the form showing their acceptance.	
Method of submitting the form to the GLRO: in person (but not limited to the Nominating officer or someone authorised to act on their behalf) or by post.	
Notification of sub-agent (all candidates)	
An election agent may appoint one or more sub-agents to act on their behalf. Election agents may appoint sub-agents for particular parts of the Greater London authority area, as long as those parts do not overlap. The election agent can determine the parts into which they wish to sub-divide the Greater London authority area.	
Give the name and address of the appointed sub-agent	
Deposit (all candidates)	
Deposit £5000 with the GLRO by 4pm on the 24 <sup>th</sup> working day before the poll.	
Confirm with the GLRO that your method of payment is acceptable.

## Notes

1. The attention of the registered nominating officer or the person authorised by him is drawn to the rules for filling up the nomination paper and other provisions relating to nomination and deposits contained in the London Members Election Rules ("LMER"), GLA Elections Rules 2007 (SI 2007/ 3541) as amended.
2. The authorised description of a registered political party is defined in Rule 7(3) of the LMER as being either the name of the party registered under s.28 of the Political Parties, Elections and Referendums Act 2000, or a description of the party registered under s.28A of that Act.
3. Where a candidate included in the party list is commonly known by some title they may be described by their title as if it were part of their surname.
4. Where a candidate included in a party list uses a name which is different from any other name they have, the commonly used name (instead of any other name) will appear on the statement of persons nominated, unless the circumstances referred to in note 5 below apply.
5. The statement of persons nominated, and the ballot paper will solely show the other name if the GLRO thinks that:
  - a) the use of the commonly used name may be likely to mislead or confuse electors, or
  - b) the commonly used name is obscene or offensive.

**Section 21 of the Greater London Authority Act 1999**

## Disqualification from being the Mayor or an Assembly member

- (1) A person is disqualified from being elected or being the Mayor or an Assembly member if--
- (a) he is a member of staff of the Authority <sup>2</sup>;
  - (b) he holds any of the offices or appointments for the time being designated by the Secretary of State in an order as offices or appointments disqualifying persons from being the Mayor or an Assembly member;
  - (c) he is the subject of a bankruptcy restrictions order or an interim order;
  - (d) he has within five years before the day of the election, or since his election, been convicted in the United Kingdom, the Channel Islands or the Isle of Man of any offence and has had passed on him a sentence of imprisonment (whether suspended or not) for a period of not less than three months without the option of a fine; or
  - (e) he is disqualified under--
    - (i) section 85A or Part III of the Representation of the People Act 1983, or
    - (ii) section 17 or 18 of the Audit Commission Act 1998,from being elected or being the Mayor or an Assembly member.
- (1A) Subsection (1)(a) does not prevent a person appointed under section 67(1)(b) as the Deputy Mayor for Fire, or appointed under section 67(1)(b) and designated as the Deputy Mayor for Fire, from being elected as or being an Assembly member.
- (2) A paid officer of a London borough council who is employed under the direction of--
- (a) any of that council's committees or sub-committees the membership of which includes the Mayor or one or more persons appointed on the nomination of the Authority acting by the Mayor, or
  - (b) a joint committee the membership of which includes one or more members appointed on the nomination of that council and one or more members appointed on the nomination of the Authority acting by the Mayor,
  - [(c) the executive or any committee of the executive of that council, where that council are operating executive arrangements and the membership of that executive includes the Mayor or one or more persons appointed on the nomination of the Authority acting by the Mayor, or
  - (d) a member of the executive of that council, where that council are operating executive arrangements and that member is also the Mayor or a person appointed on the nomination of the Authority acting by the Mayor,
- shall be disqualified from being elected or being the Mayor or an Assembly member.
- [(2A) In this section "executive" and "executive arrangements" have the same meaning as in Part II of the Local Government Act 2000.
- (3) ...\*
- (4) ...\*
- (5) For the purposes of subsection (1)(d) above--
- (a) the ordinary date on which the period allowed for making an appeal or application with respect to the conviction expires, or
  - (b) if such an appeal or application is made, the date on which the appeal or application is finally disposed of or abandoned or fails by reason of its non-prosecution,
- shall be deemed to be the date of the conviction.
- (6) This section shall apply in relation to being returned as a London member under section 11 above otherwise than at an election as it applies in relation to being elected.
- (7) References in this section to election shall accordingly be construed as if a London member so returned were elected at an election on the day on which he is to be treated as returned.

**Section 34 of the Localism Act 2011**

## Offences

- (1) A person commits an offence if, without reasonable excuse, the person—
  - (a) fails to comply with an obligation imposed on the person by section 30(1) or 31(2), (3) or (7),
  - (b) participates in any discussion or vote in contravention of section 31(4), or
  - (c) takes any steps in contravention of section 31(8).
- (2) A person commits an offence if under section 30(1) or 31(2), (3) or (7) the person provides information that is false or misleading and the person—
  - (a) knows that the information is false or misleading, or
  - (b) is reckless as to whether the information is true and not misleading.
- (3) A person who is guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 5 on the standard scale.
- (4) A court dealing with a person for an offence under this section may (in addition to any other power exercisable in the person's case) by order disqualify the person, for a period not exceeding five years, for being or becoming (by election or otherwise) a member or co-opted member of the relevant authority in question or any other relevant authority.
- (5) A prosecution for an offence under this section is not to be instituted except by or on behalf of the Director of Public Prosecutions.
- (6) Proceedings for an offence under this section may be brought within a period of 12 months beginning with the date on which evidence sufficient in the opinion of the prosecutor to warrant the proceedings came to the prosecutor's knowledge.
- (7) But no such proceedings may be brought more than three years—
  - (a) after the commission of the offence, or
  - (b) in the case of a continuous contravention, after the last date on which the offence was committed.
- (8) A certificate signed by the prosecutor and stating the date on which such evidence came to the prosecutor's knowledge is conclusive evidence of that fact; and a certificate to that effect and purporting to be so signed is to be treated as being so signed unless the contrary is proved.
- (9) The Local Government Act 1972 is amended as follows.
- (10) In section 86(1)(b) (authority to declare vacancy where member becomes disqualified otherwise than in certain cases) after "2000" insert "or section 34 of the Localism Act 2011".
- (11) In section 87(1)(ee) (date of casual vacancies)—
  - (a) after "2000" insert "or section 34 of the Localism Act 2011 or", and
  - (b) after "decision" insert "or order".
- (12) The Greater London Authority Act 1999 is amended as follows.
- (13) In each of sections 7(b) and 14(b) (Authority to declare vacancy where Assembly member or Mayor becomes disqualified otherwise than in certain cases) after sub-paragraph (i) insert—
  - (ia) under section 34 of the Localism Act 2011,".
- (14) In section 9(1)(f) (date of casual vacancies)—
  - (a) before "or by virtue of" insert "or section 34 of the Localism Act 2011", and
  - (b) after "that Act" insert "of 1998 or that section".
